

大肚溪口野生動物保護區範圍內，禁止非法獵捕螃蟹及野生鳥類  
違者罰新臺幣 5 萬元以上 25 萬元以下罰鍰或處 6 個月以上 5 年以下  
有期徒刑

(依據野生動物保育法相關規定)

Illegal hunting of crabs and wild birds is prohibited within the Dadu  
Creek end Wildlife Protection Area

Offenders will be fined NT\$50,000 to NT\$250,000 or sentenced to fixed-  
term imprisonment of not less than 6 months but not more than 5 years  
(According to the relevant provisions of the Wildlife Conservation Law)

#### 第 41 條

非法獵捕、宰殺保育類野生動物者

(處 6 個月以上 5 年以下有期徒刑，得併科新臺幣 20 萬元以上 100  
萬元以下罰金。於野生動物保護區內犯罪者，加重其刑至三分之  
一。

#### Article 41

Those who illegal hunting and killing of protected wild animals  
(Imprisonment of not less than 6 months but not more than 5 years may  
be imposed, and a fine of not less than NT\$200,000 but not more than  
NT\$1,000,000 may be imposed. Those who commit crimes in wild  
animal protection areas shall have their punishment increased to one-  
third.)

#### 第 42 條

非法騷擾、虐待保育類野生動物者

(處 1 年以下有期徒刑、拘役或科或併科新臺幣 6 萬元以上 30 萬元  
以下罰金；其因而導致野生動物死亡者，處 2 年以下有期徒刑、拘  
役或科或併科新臺幣 10 萬元以上 50 萬元以下罰金。於野生動物保  
護區內犯罪者，加重其刑至三分之一。

#### Article 42

Those who illegally harass and abuse endangered wild animals  
(Sentenced to fixed-term imprisonment of not more than 1 year, criminal  
detention or a fine of NT\$60,000 to NT\$300,000; those who cause the  
death of wild animals shall be sentenced to fixed-term imprisonment of  
not more than 2 years, criminal detention or a fine of NT\$100,000 to NT\$  
500,000. Those who commit crimes in wild animal protection areas shall  
have their punishment increased to one-third.)

非法獵捕、宰殺一般類野生動物者  
(處新臺幣 5 萬元以上 25 萬元以下罰鍰)

非法騷擾、虐待一般類野生動物者  
(處新臺幣 2 萬元以上 10 萬元以下罰鍰)

Article 50

Those who illegally hunting and killing of general wild animals  
(A fine ranging from NT\$50,000 to NT\$250,000)

Those who illegally harass and abuse general wild animals  
(A fine ranging from NT\$20,000 to NT\$100,000)
